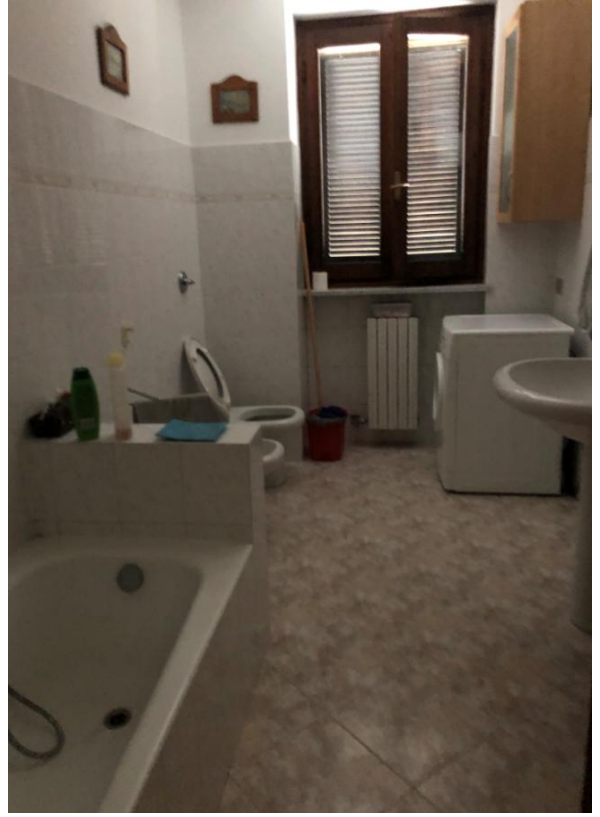






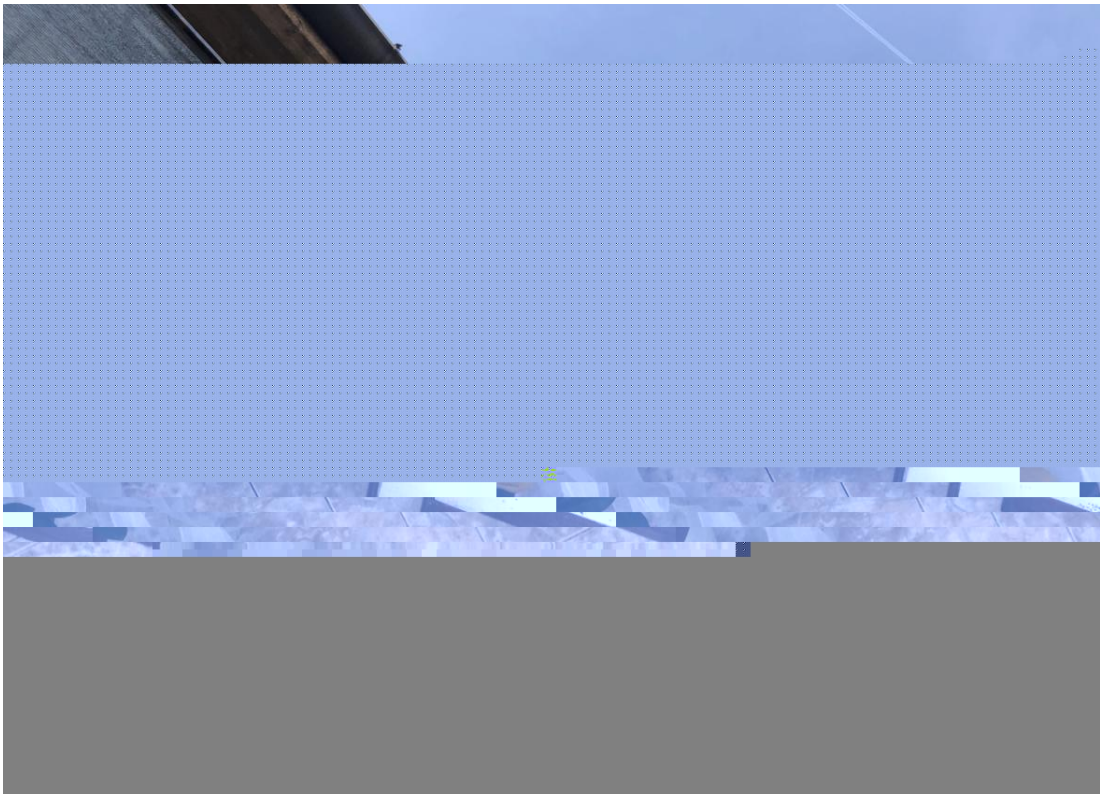


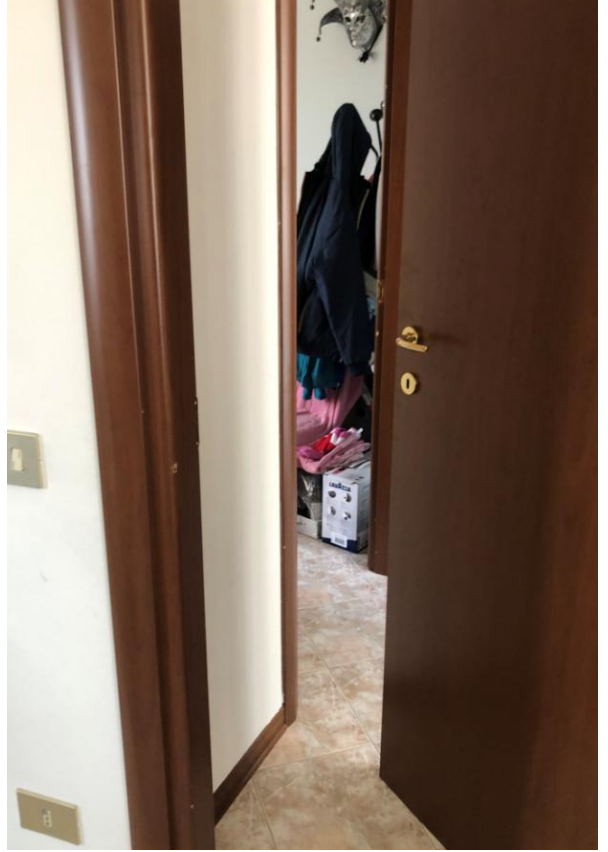


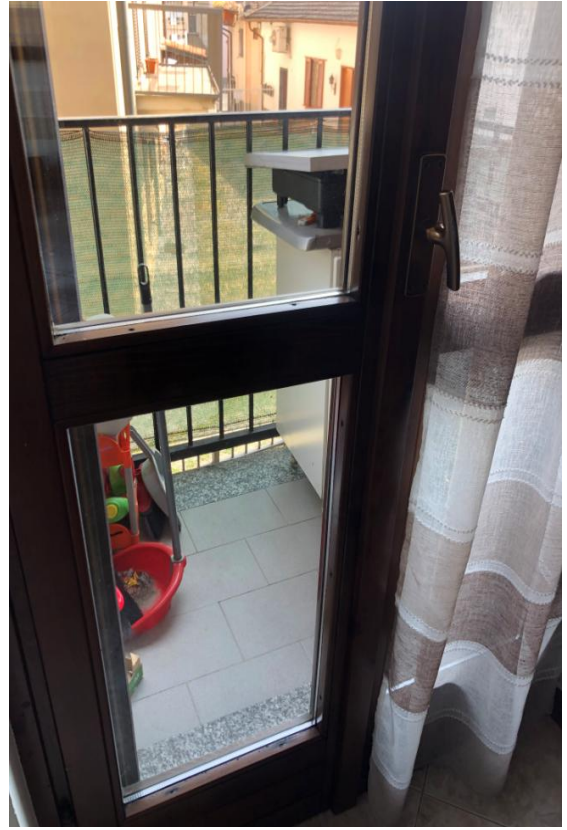
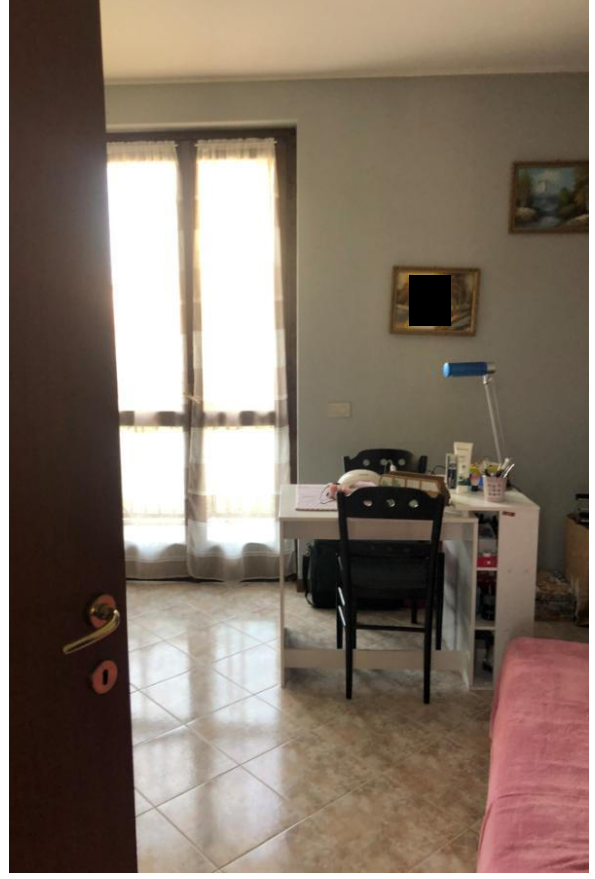


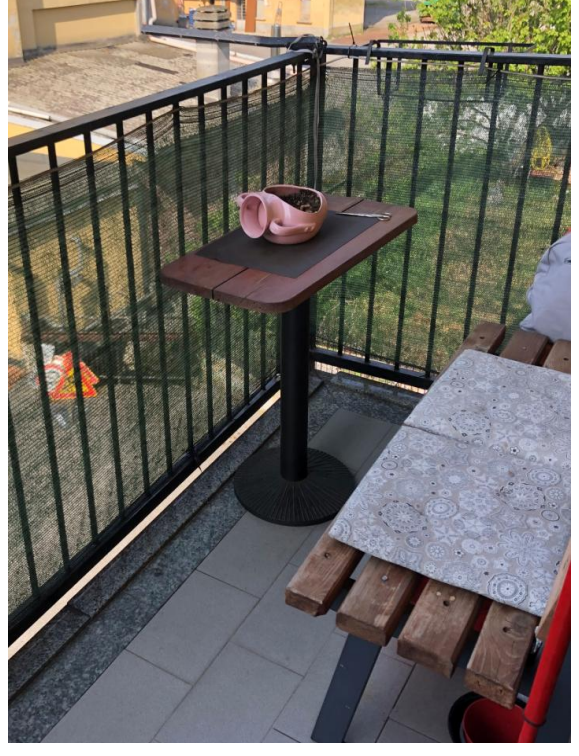


Foglio 9 Mapp. 1677/2 (ex mapp. 190/2-191/2) V. S. Giorgio 226 A/3 vani 3,5

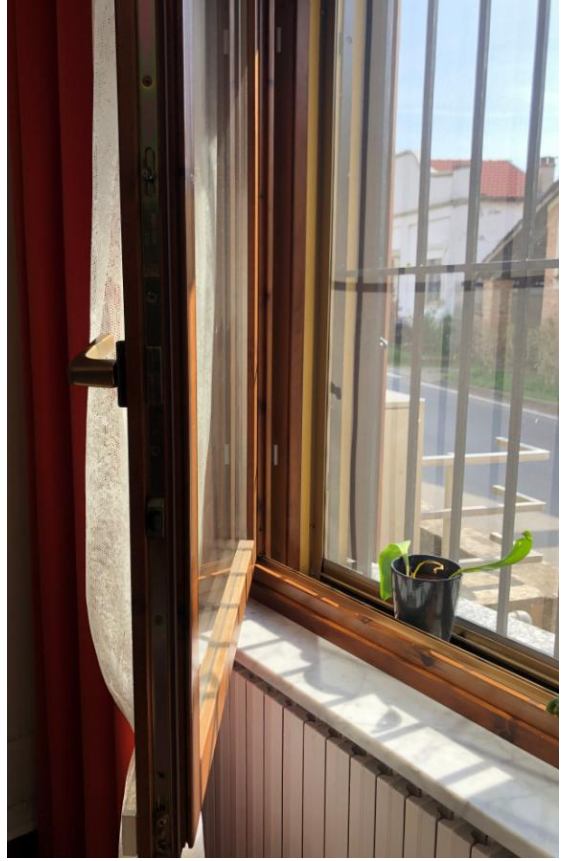




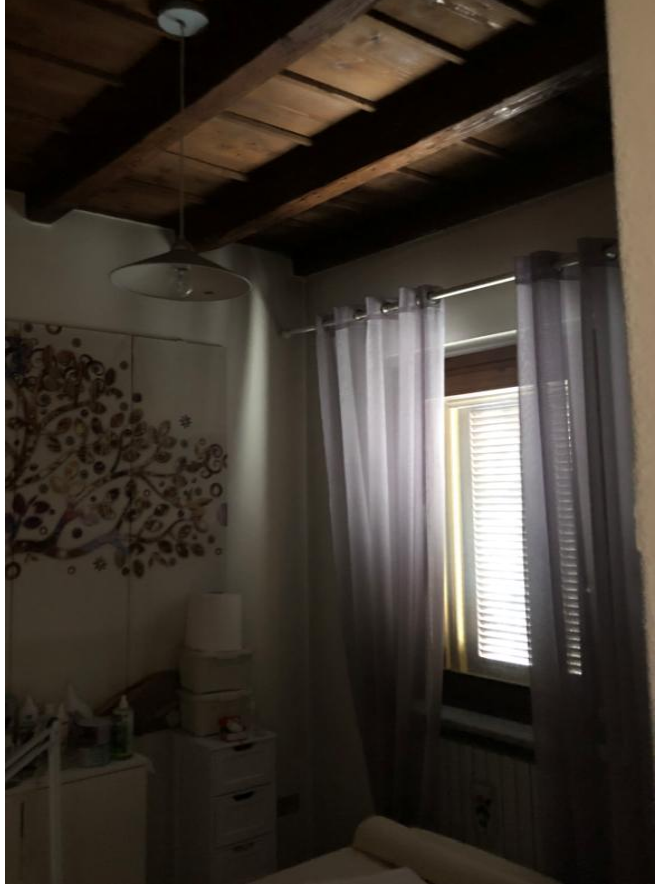
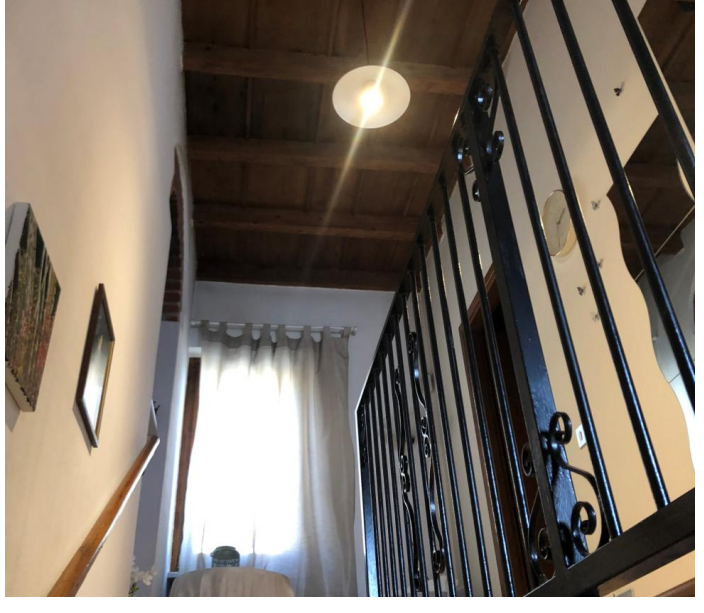


Foglio 8 Mapp. 1296/11 V. S. Giorgio 217 A/3 vani 5,5







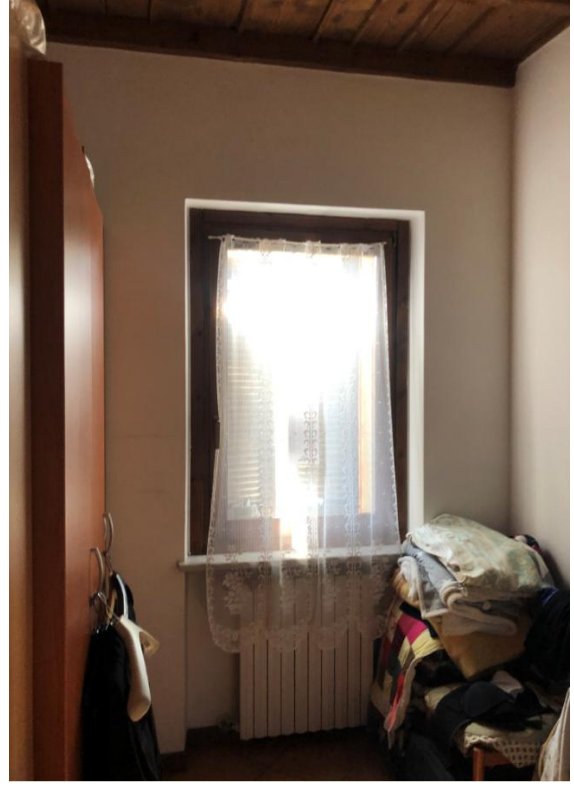

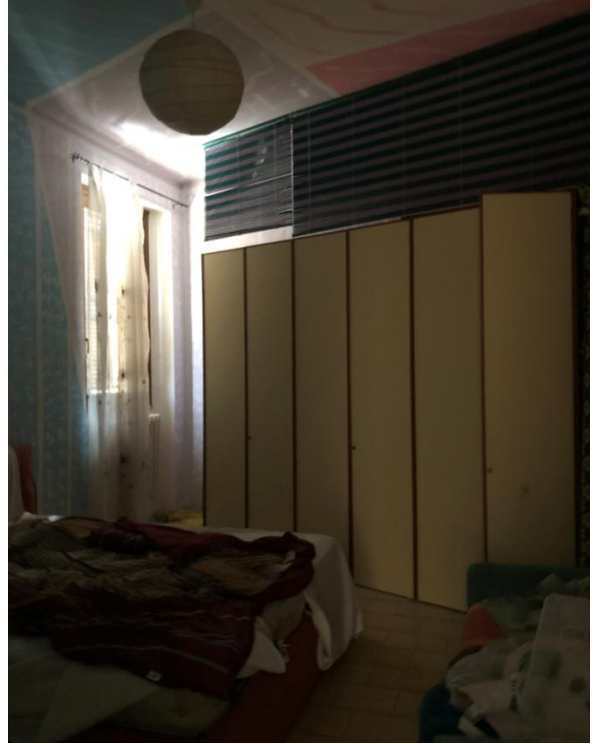


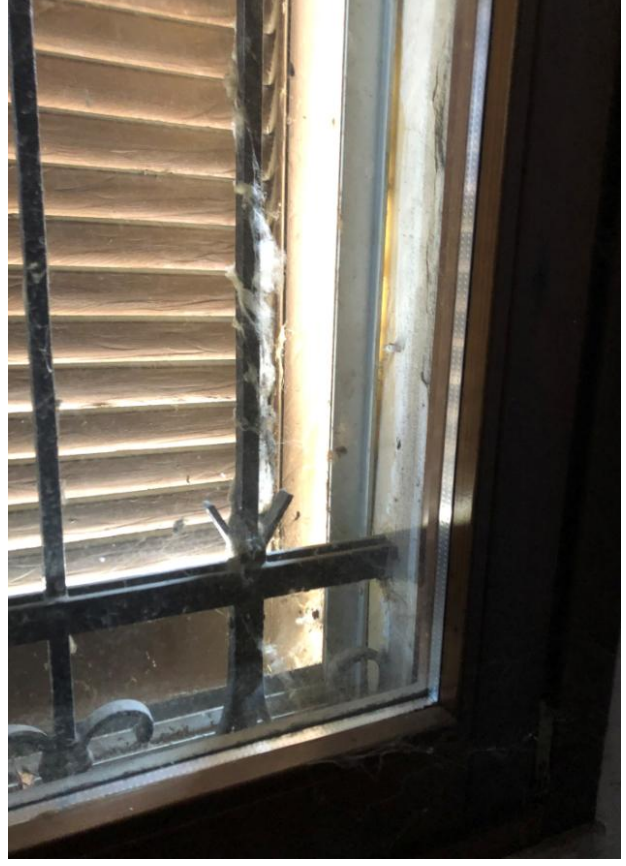


Foglio 8 - Mapp. 1293/4 V. S. Giorgio 207 A/3 vani 4





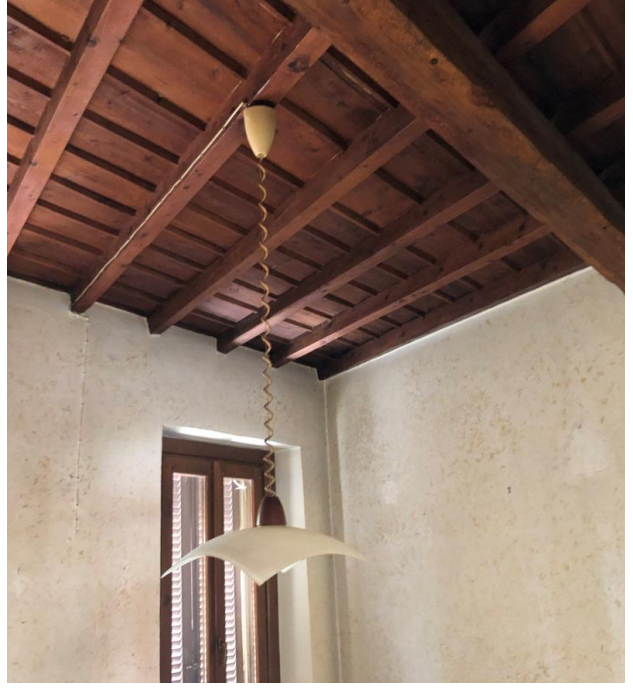


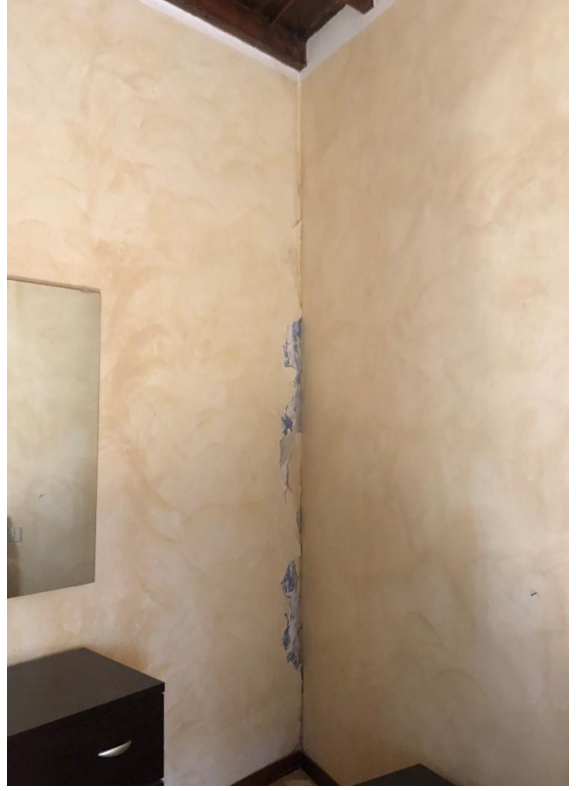


Foglio 8 - Mapp. 1293/5 V. S. Giorgio 207 A/3 vani 4
